Mankato Family YMCA Release & Waiver of Liability Indemnity Agreements

In consideration of gaining membership or being allowed to participate in the activities and programs of the YMCA and to use its facilities, equipment, and machinery in addition to the payment of any fee or charge, I do hereby waive, release, and forever discharge the YMCA and its officers, agents, employees, representatives, executors, and all others from any and all responsibilities or liability for injuries or damages resulting from my participation in any activities or my use of equipment or machinery in the above-mentioned facilities or arising out of my participation in any activities at said facility. I do also hereby release all of those mentioned and any others acting upon their behalf from any responsibility or liability for any injury or damage to myself, including those caused by the negligent act or omission of any of those mentioned or others, acting on their behalf or in any way arising out of or connected with my participation in any activities of the YMCA or the use of any equipment at the YMCA. I agree to adhere to all policies set by the YMCA as written in the YMCA Membership Handbook.

Parent/Guardian Authorization

1. In the event that my child needs immediate medical attention for injuries received while participating in a YMCA program, or when a parent cannot be reached or is delayed, I authorize the YMCA staff to give my child reasonable first aid, and to arrange transportation of my child to a health care facility for emergency services as needed.
2. I agree to the release of records necessary for treatment, referral, billing or insurance purposes. The YMCA receives medical information on participant that may need to be shared with medical providers.
3. My child has my permission to be transported by the YMCA as needed for field trips, inclement weather, or late pickup. I also give my child permission to participate in walking field trips.
4. I hereby acknowledge that the YMCA will assume that either parent of the child may pick up the child at any time during the program unless there is pertinent court documentation on file at the YMCA that indicates otherwise.
5. I hereby release all pictures and video footage of my child taken by the YMCA for promotional purposes and programming materials including the YMCA website and social media.
6. If my child requires use and administration of an Epi-pen, it is my responsibility to ensure that the Epi-pen is given to the Preschool Director by the first day of preschool. If YMCA staff is required to administer and use the Epi-pen, I agree to forever release and discharge the YMCA and its directors, officers, and employees from any and all liability arising out of or resulting from use or administration of the Epi-pen.
7. I give my permission for the YMCA to administer sunscreen, bugspray, Vaseline, lip balm and hand sanitizer as needed.

Registration Agreement

I understand this registration form holds my child's spot in YMCA Preschool until all Health and Financial forms are turned in. Information on how to complete these required forms will be emailed to the email listed on this form at the end of May. Completed forms are to be returned to the Mankato Family YMCA by July 15th of the current year. If completed Health and Financial forms are not returned by July 15th, I realize I may forfeit my child's spot in YMCA Preschool. If it is necessary that my child drops from preschool, I understand a 30 day written notice is required and I am responsible for tuition until the end of the 30 days.
